NOTICE IS HEREBY GIVEN, pursuant to 551.041 of the Texas Government Code, that the Navigation District and Canal Commissioners of the WEST SIDE CALHOUN COUNTY NAVIGATION DISTRICT will meet at 7:00 pm on the 18th day of August 2020 at District offices, 402 S Main Street, Seadrift, TX.

 - b. Receive information regarding Long Mott Harbor master plan process
 - c. Information or updates on Rider 38 grant project
- 8. To discuss operational needs of Leaseholders at Seadrift Harbor; review available infrastructure; review the usage and development of the Harbor, and take appropriate action.
- 9. To discuss bulkheading and repairs at Seadrift Harbor, and take appropriate action.
- 10. To discuss Long Mott Harbor master planning process and proposals, and take appropriate action.
- 11. To consider authorization of a public bidding process for agricultural lease at property adjacent to the District's Long Mott Harbor, off Hwy 185, and take appropriate action.
- 12. To discuss District Policies regarding handling and sales of shrimp, fish, and other seafood commodities at Seadrift Harbor, and take appropriate action.
- 13. To discuss real estate matters of interest to the District and take appropriate action
- 14. To conduct the regular business of the District and that relating to its properties
